Business:

- Group runs will continue to be on Sundays at 0800am at the Greenway unless otherwise specified. On some Sundays, Tracee will be there at 0700am to run with those who want to get a longer or earlier run in.
- Fleet Feet will continue to have it's 10% discount for active and current CRC members who can show their membership card at checkout.
- Tracee would like to get new team tshirts. Tracee will look at vendors for prices and designs and will present it to members at the next meeting.
- We only received 1 full scholarship applicant. They will be the only Mike O'Hara Scholarship Recipient for 2024. We will award them at a later date.
- We will be changing CRC meeting locations to Star Spangled Brewing at the North Spring Street location.
- We need to reassess our timing fees. Ted and Jim will look into this and come up with a rubric. Previously proposed was \$650 for a 5k of 300 runners or less, and \$100 for a 10k of 50 runners or less with additional fees for extra runners. They will reexamine these numbers and come up with a fee schedule by increment for amounts of runners that surpass the 300/50 amounts.
- The website is still a work in progress. Tracee is going to ask Liz Snodgrass for direction in finding someone who can finish putting it together.

-2024 Pass The Turkey:

- We need to doublecheck whether or not we still have approval from the Governor's Square Mall.
- We need to get date specific event insurance filed through the RRCA.
- We need to decide if we will offer hats again or something else (or nothing at all).
- Supplies, portajohns, volunteers, etc. will be addressed once we confirm with the mall that we have permission.

- 2024 Wilma Rudolph Charity Run:

- The majority of the board members have conflict with the suggested date of 14 September, 2024.
- It was agreed by members present at this meeting that the race should be scrapped for this year but we will continue on with planning for 2025.
- 21 June, 2025 is the new proposed date. 1. Tracee will request the date from Andy Keane. 2. Once he confirms that is available, we need to file for date specific event insurance from the RRCA. 3. Once we have that, we will file for a permit from the City of Clarksville. 4. Once our permit is accepted, we present Andy with all the needed information. 5. Once Andy has all the necessary information and documents, he can formally lock in the date for us. 6. Then the real fun begins with organizing volunteers, supplies, etc.
