Approval of Minutes:

Motion to approve minutes from 21 July by Jim Galloway and seconded by Miriam Mengden.

Business:

- Group runs will continue to be on Sundays at 0800am at the Greenway unless otherwise specified. On some Sundays, Tracee will be there at 0700am to run with those who want to get a longer or earlier run in.
- The new location for CRC meetings is Star Spangled Brewing at the North Spring Street location.
- The website is still a work in progress.
- We were approached by a local Rotary club that wanted to hold a 5k race. There are no details yet, but they want us to time it. Tracee will send them a contract once there is more information.
- Tracee expressed the desire to hold a volunteer banquet, probably in January. It would be invitation only and Tanglewood House was discussed as the location. Details to follow as she finds out more information.
- The 5th Group SFRG is planning to do a 5k on 21 September, 2024. They would like for us to time but need a timing contract with our fee schedule, etc.
- We discussed timing fees.
 - The fee schedule will be:
 - \$650 for a 5k of up to 300 people
 - \$750 for a 10k of up to 300 people
 - For a 5k and 10k combo of up to 300 people, it will be \$800 if the races start at the same time.
 - For a 5k and 10k combo of up to 300 people, it will be \$900 if the races have a staggered start with no more than 90 minutes in between the separate start times.
 - It will be an extra \$100 fee for each extra batch of registrants in 100 person increments that go above 300. For example it would be an extra \$100 for 301-399 participants and so on.
 - There will be an extra \$100 fee if the race director doesn't send us the registrations by midnight on the Thursday before a Saturday race (or 48 hours in advance depending on the weekday the race is on).

- Dorothy Galloway proposed the motion that we adopt this fee schedule for timing races. Denise Dudley seconded the motion. Present club members voted and approved this measure.
- Ted Engeman and Jim Galloway will draw up an official timing contract that will be voted on at the September CRC meeting.

-2024 Pass The Turkey:

- 28 November, 2024.
- We need to doublecheck whether or not we still have approval from the Governor’s Square Mall.
- We have submitted for date specific event insurance filed through the RRCA.
- Tracee is looking into offering gloves to match the hats we had last year.
- Supplies, portajohns, volunteers, etc. will be addressed once we confirm with the mall that we have permission.

- 2024 Wilma Rudolph Charity Run:

- Tracee has made contact with Andy. He will request that 21 June, 2025 be reserved for our race. The backup date will be 14 June, 2025.
